Judgement and Order. Writ of Execution

***Claimant: reign of the heavens society Temple v.

WHEREAS, the General Post Master Council has determined that the evidence presented (through the writings of the Respondent show beyond a reasonable doubt that the Respondent convicts herself) for the following crimes including but not limited to attempted murder wherein the respondent has jeopardized the public safety and well-being of thousands of people with the arbitrary accusation of piracy vacant any evidence and is hereby also charged with wanton reckless endangerment, and

WHEREAS, the National assembly for the Government of The United States of America has assessed value of this case in the total amount of Twenty Two Million Five Hundred Thousand CD, (22.5 million) or equivalent, to be paid in assets of value, payable in Legal Tender, land or cured trust property under the classification of a fine allocated towards damages caused by these crimes.

WHEREAS, Violation of all 30 Public Laws-101 assessed value- 22.5 million. The Respondent has committed violations against the Public Laws-101 of The United States of America.

JUDGMENT

NOW THEREFORE:

BE IT JUDGED, that the Great Jury True Bill of Indictment brought to the General Post Master Council is evidence of violations of all Public Laws-101. The evidence proves that the Respondent did repeatedly bear false witness to instigate attempted mass murder Including threats to incite violence, International terrorism, and rebellion toward the Claimant. The Respondent stands in default through non response to the General Post Master Council.

ORDERS

BE IT ORDERED, that the Respondent, is under arrest and sentenced to 13 years(added on to the end of a current sentence of 37 years) and a fine of +22.5 million CD for attempted murder of a population which violates all 30 of the Public Laws-101, and against the sovereign social compact of a foreign body politic, and

FURTHER BE IT ORDERED, that the U.S. Citizens who have paid money to the Respondent for fraudulent freedom documentation produced from Respondent can claim damage within this settlement. Upon receipt of Affidavit with evidence of damage, the Treasury for The United States of America is authorized to reimburse the theft of money by Respondent with reference to this case#. The reimbursed money will be in Continental Dollars, and

FURTHER BE IT ORDERED, that all sovereignty, nationality, freedoms, liberties, rights, privileges, immunities, reputation and international character are in good standing. Peace is hereby upheld to the claimant because the un-rebutted claim of existence for the reign of the heavens, and The United States of America stands as evidence in fact to these Countries rightful place among the Nations, and

FURTHER BE IT ORDERED, that any further evidence of violations of the Public Laws-101 or any other deprivation of character will be sent to the Law Department of the American National Union for The United States of America for further review for possible further charges under Public Law and or international law, and

FURTHER BE IT ORDERED, that no retaliation or harassment against the reign of the heavens Temple and the Government of The United States of America, its office holders, or any other citizen of the reign of the heavens, or American National shall be tolerated, any and all retaliation by any and all shall be resisted with automatic arrest of the Public Law violator and tried in this General Post Master Council immediately upon a proper affidavit and evidence to support the violation, and

FURTHER BE IT ORDERED, that any articles on the internet that attempt to distort the history of The United States of America, the Government of The United States of America, and the American Nationals thereof, is an attempt to interfere with the Social Compact Agreement of its people and is an act of terrorism against The United States of America and in violation of the Public Laws-101, and



FURTHER BE IT ORDERED, that the Law Department of the American National Union for The United States of America reserves the right to utilize this Judgment and Order and any and all evidence herewith in any future charges or court actions in this or other court of Law.

FURTHER BE IT ORDERED, that an assessment for damages be sent to The office of the Treasury for The United States of America, Global Postal Code: NAC: 850H2 MR7C8-0007, The United States of America For the purpose of attaching a fine for the monetary damages associated with Violations of all 30 Public Laws-101 of The United States of America

GENERAL ORDER

FURTHER BE IT ORDERED UNDER GENERAL ORDER: that any and all Foreign Monarchs, Governments, incorporated and/or unincorporated Associations, Agencies or agents thereof are hereby ordered to cease and desist any and all interference or disruptive actions towards The reign of the heavens, the reign of the heavens Temple, citizen of the reign of the heavens, The United States of America, the Government of The United States of America, American Nationals, the Social Compact Agreement of its Nationals, the power of attorney, its Law form, and freedoms thereto, and

Therefore, by the authority vested in the General Post Master Council by the National assembly of the Government of The United States of America, the following is hereby declared:

That, this judgment and order is hereby executed upon the default of respondent, and that the evidence presented is beyond a reasonable doubt. All damages are immediately due and payable to the Treasury for The United States of America. And,

That, if after 90 days, these damages remain unpaid, this judgment shall stand as a lien until satisfied.
