## EXECUTIVE ORDER - B6F13A38

By the Executive power vested in the National assembly for the Government of The United States of America, the following is hereby ordered:

That the States of the Union and The United States of America are not accepting any obligations or rights as it pertains to the Paris Agreement, done at Paris on December 12, 2015, also known as Paris Climate Agreement entered into by Joseph Robinette Biden Jr.. Any and all orders or acceptance of obligations or rights within the aforementioned agreement to the contrary are hereby classified as canceled foreign instruments thereby issued by an unauthorized and foreign totalitarian dictatorship.
