

## Declaration of Independence

From The Government of The United States of  
America JANUARY 06, 2021

*We hold these truths to be self-evident, that all men are created equal, that they are endowed by their Creator with certain unalienable Rights, that among these are Life, liberty, the pursuit of Happiness, and ownership of Private Property.*
